Specifically the land near our property was intended to be transformed into an orchard.

Please can the PC confirm whether this is still the intention for this land and if so, what timelines you are currently working towards to adopt it?

I had learned from a neighbour that the PC might consider alternative options for this land including potential sale to local residents. If this is accurate, I would welcome a further discussion
