It is time for Stratford-on-Avon District Council to create a new Council Plan to provide its directions for the next four years, and we need your help please.

Since the local elections in May of this year, the Council has been working with key stakeholders (both internal and external) to produce a set of aims and objectives that look to have a positive impact for residents, communities, and businesses in the district.

We are also setting a wider vision for the Council. Obviously in setting this long-term vision your views and those of your councillors are important. This is your opportunity to have your say in relation to the ambitions for Stratford-on-Avon District and we urge you to participate in this short consultation.
